Thank you for your email. To answer your questions, the two books referenced in your email are not in circulation in West Ada School District Libraries. Books are selected for our libraries and can be challenged by patrons through the processes outlined in Board Policy 602.21 Selection and Reconsideration of Learning Resources and Administrative Regulation 0602.21-AR(1): Selection and Reconsideration of Learning Resources. As outlined in 602.21AR, when a librarian or teacher is selecting a book or learning resource, they shall do the following:

- Consult reputable, professional sources to help determine if the resource is appropriate for its anticipated use. See the library resources webpage on the district website for resources.
- Review existing district-wide school library collections to determine if the resource is already available at commensurate sites, (e.g., elementary schools, middle schools, or high schools).
 This can be done in Destiny Library Manager which can be accessed through the My Apps portal.
- If the items do exist at a similar site based on age and grade levels, then they are suitable for

inclusion in your classroom library or site library.

- If they do not appear in the library catalog at an appropriate grade level, then proceed with submitting the items for public feedback to the District Library Coordinator by completing the Book Request Tracker, accessible for all staff through the district Web Apps Portal.
- If no comments are received, the librarian or teacher can proceed with the utilization of the book or learning resource.
- If comments are received, the book or learning resource will be referred to the Standing Instructional Resources Committee for review.
